3 **What is AAPFCO?**

4 The Association of American Plant Food Control Officials is open to each state, territory,
5 dominion, province, federal or governmental entity on the North American Continent, Hawaii
6 and Puerto Rico charged by law with enforcing laws relating to the control of, sale & distribution
7 and examination of mixed fertilizers and fertilizer materials.

8

9 **Why AAPFCO?**

10 Each state agency's program is different yet each is similar. That is why we are here, to become
11 more consistent in the individual state regulations for the public, consumer, and industry. There
12 is not a federal agency that oversees the fertilizer industry. The feed industry has FDA and the
13 pesticide group has EPA.

16 **The Goals of AAPFCO are to:**

- 17 • Provide uniform fertilizer regulation to help the fertilizer industry more easily comply
- 18 with each state
- 19 • Protect consumers
- 20 • Promote environmental stewardship [HOW]

22 **The Purpose of AAPFCO is to:**

- 24 • Encourage adoption of Official Analytical Methods
- 25 • Develop High Standards of Fert Inspection
- 26 • Promote Adequate Labeling of Fertilizers
- 27 • Provide facilities for Free Exchange of Info
- 28 • Cooperate to promote usefulness
- 29 • Adopt new plant food terms and definitions

31 **Who AAPFCO is:**

- 32 • Plant Food regulatory agencies from the US, Puerto Rico & Canada
- 33 • Industry Liaisons; Non-voting members

36 Board membership is a 6 year commitment

44 **Meetings:**

45 AAPFCO holds 3 meetings every year:

- 46 • Summer Annual = End of July or early August;

- 1 ○ Generally in conjunction with the Feed Control Official meeting. AAFCO
- 2 • Winter Annual = Mid February
- 3 ○ Immediately following the Winter Annual there is a Methods Forum
- 4 conference for state control lab officials and industry lab members
- 5 • AAPFCO Seminar for control officials in the fall
- 6 ○ Seminar focuses on training and learning to understand each state's laws and
- 7 why there are in place. Identifying and understanding the differences is a
- 8 driver for uniformity.
- 9

10 Purpose of the business meetings are for the committees to work transparently and develop
11 working relationships and documents to move through the association for review and
12 consideration of adoption.

13
14 Most committee meetings are open to the all that attend the meeting. The committee members
15 sit up front, generally around a U shaped table while others attending sit throughout the room.
16 Discussion is controlled by the chair and facilitator with comments first coming from the
17 committee members then from the audience.

18
19 A very important supplemental benefit is the networking opportunities, connecting with Control
20 Officials and liaisons which makes it easier to reach out to when questions/problems arise.
21 (Huge benefit for people new to this position!)

13 **The Official Publication (OP) = Plant Food Control Bible**

14 Between the covers of the OP lie the history and the heart of AAPFCO.

15 The history includes those that have served before us and have laid the foundation for us
16 to build and grow the organization.

17 The heart describes the Association's by-laws, policies and officially adopted documents.
18 These include the Uniform Fertilizer Bill, Official Terms and Definitions, Statements of
19 Uniform Interpretation and Policy, state by state regulatory overview & contact
20 information and many other items that are invaluable tools and references in the plant
21 food control world.

22 The OP also contains proceedings from previous meetings

24 **How items move through the association to become part of the Official Publication.**

25 Committees strive to work together (Control Officials and Industry Liaisons) to interpret,
26 develop, and disseminate useful information for all involved; control officials, industry,
27 the public and the environment.

29 Each committee has a charge, goals and a set of objectives when they meet twice a year;
30 summer annual and winter annual meetings. Committees often collaborate through email
31 and conference calls to more efficiently develop and refine working documents until they
32 propose by vote to move some item to tentative. That item will then go to the board of
33 directors and finally to the membership.

35 Once all 3 groups have moved an item to tentative it then must follow the same path to
36 before official. At each annual meeting a tentative proposal must be voted on by the
37 committee to keep it tentative, delete or move to official.

Who gets to vote:

While industry liaisons are welcomed and valuable committee members, only committee members that are control officials are allowed to vote.
Please see the Operations Manual for voting procedures and guidelines for committee operations.
